1. Roll call and excuse absence of committee members.	The meeting was called to order at 9:03am on April 3, 2025. The roll was called and a quorum was present. A motion was made by Louie Havens to excuse the absence Desha Turner. The motion was seconded by Chuck French. The motion carried.
2. Approval of Committee meeting minutes from the January 29, 2025 meeting.	Louie Havens made a motion to accept the minutes from the January 29th, 2025 meeting as submitted. The motion was seconded by Buddy Rice. The motion carried.
3. Discussion and possible action on TEEX courses.	Discussion was had regarding what kind of timeline should be implemented to show courses on the website that no longer exist. Buddy Rice made a motion, which was seconded by Sam Baucom, to add the new, amended courses provided and leave the old courses in place. The motion carried.
4. Discussion and possible action on Hazardous Materials Ad Hoc applications.	Item four was decided to be addressed after discussion could be held in Executive Session. A request was made of staff to provide C&T Committee members with documents from staff and documents from previous committee members to be analyzed and merged for future discussion. A motion was made by Louie Havens, and seconded by Chuck French, to table item eight until next meeting. The motion carried.
9. Discussion and possible action on committee expectations guide.	Discussion was had regarding the two internal Committee Expectations documents created for the C&T Committee and the Ad Hoc committees. A motion was made by Buddy Rice to adopt these Expectations documents, and it was seconded by Jacob Smith. The motion carried.
10. Discussion and possible action related to Fire Investigator	Charai Fernandez gave an update on the Curriculum and Skills manuals that were revised by the Investigator committee. Louie Havens made a motion to approve the Curriculum and Skills manual updates made by the Investigator committee. The motion was seconded by Chuck French. The motion carried.

Discussion was had and updates were given regarding each listed certification and where their Ad Hoc committee is currently regarding required updates. Sam Baucom gave an update on the next steps for the Aircraft Rescue Fire Fighter (ARFF) Ad Hoc Committee. Buddy Rice gave an update on the Inspector, Plan Examiner, and Fire and Life Safety Educator, and Fire Marshal Ad Hoc committees which are making great progress. Chris Watson spoke on the updates being made currently to the Driver/Operator curriculum and addressed Instructor, Fire Officer, and Incident Safety Officer also. It was discussed that the Water Rescue Ad Hoc committee has their initial meeting scheduled for May 6, 2025 and Sam Baucom will be acting as liaison for them. Louie Havens gave an update on the Emergency Manager Ad Hoc committee and the progress that is already being made in establishing that curriculum. Updates were given on the small test question sub-committee that was created by C&T to review test questions and make necessary updates to the test banks.
